

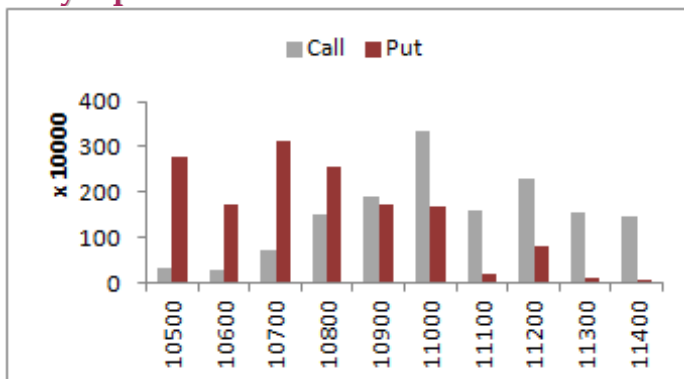

Nifty Options OI Distribution



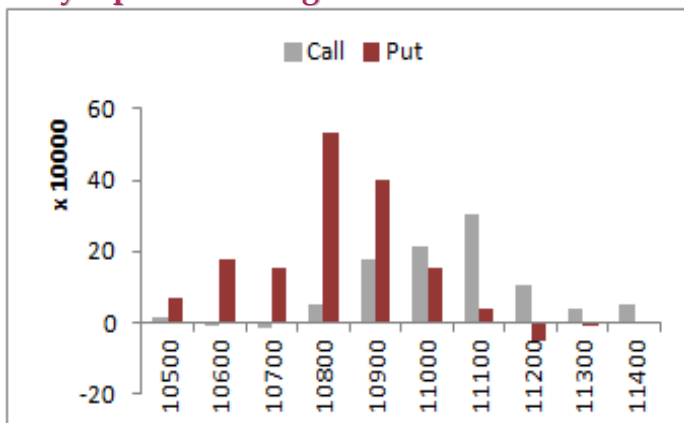
HIGHLIGHTS: Nifty futures closed at 10937.50 on a positive note with 1.86% increase in open interest indicating Long Build Up. Nifty Futures closed at a premium of 25 points compared to previous day premium of 20 points.

FII's were Sellers in Index Futures to the tune of 185 crores and were Buyers in Index Options to the tune of 1187 crores, Stock Futures were Buyers to the tune of 111 crores.

FII's were Net Buyers in derivative segment to the tune of 1246 crores.

India VIX index is at 15.72 Nifty ATM call option IV is currently at 12.04 whereas Nifty ATM put option IV is quoting at 16.13.

Index options PCR is at 1.67 and F&O Total PCR is at 0.99.

Among stock futures DHFL, BATAINDIA, SRF & AMARRAJABAT have witnessed long build up and may show strength in coming session.

Stock which witnessed short build up are CONCOR, VGUARD, RPOWER & MARICO may remain weak in coming session.

Nifty Put options OI distribution shows that 10700 has highest OI concentration followed by 10400 & 10500 which may act as support for current expiry.

Nifty Call strike 11000 followed by 11200 witnessed significant OI concentration and may act as resistance for current expiry.
