## Nifty Daily Chart



### Comments:

Nifty opened on a positive note however selling pressure from opening tick dragged index lower to close near the day's low. Nifty closed at 11844 with a loss of 178 points.

On the daily chart index has formed a sizable bearish candle forming lower High-Low compare to previous session and has closed below previous session's low indicating negative bias. The index is moving in a Higher Top and Higher Bottom formation on the daily chart indicating sustained up trend. The chart pattern suggests that if Nifty crosses and sustains above 11900 levels it would witness buying which would lead the index towards 11930-11970 levels. However if index breaks below 11830 level it would witness selling which would take the index towards 11800-11750. Nifty is trading above 20, 50 and 100 day SMA's which are important short term moving averages, indicating positive bias in the short to medium term. Nifty continues to remain in an uptrend in the short and medium term, so buying on dips continues to be our preferred strategy.

The daily strength indicator RSI and momentum oscillator Stochastic have both turned negative and are below their respective reference lines indicating negative bias

The trend deciding level for the day is 11905. If NIFTY trades above this level then we may witness a further rally up to 11980-12115-12190 levels. However, if NIFTY trades below 11905 levels then we may see some profit booking initiating in the market, which may correct up to 11770-11695-11560 levels
