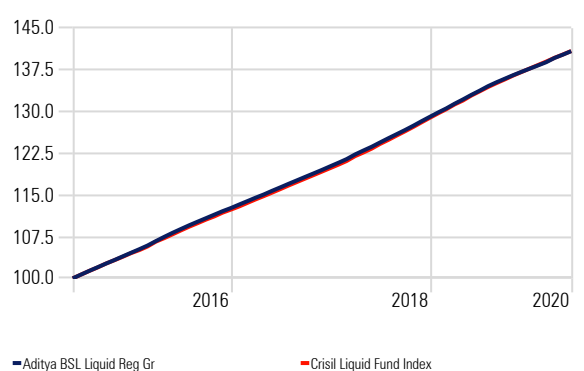

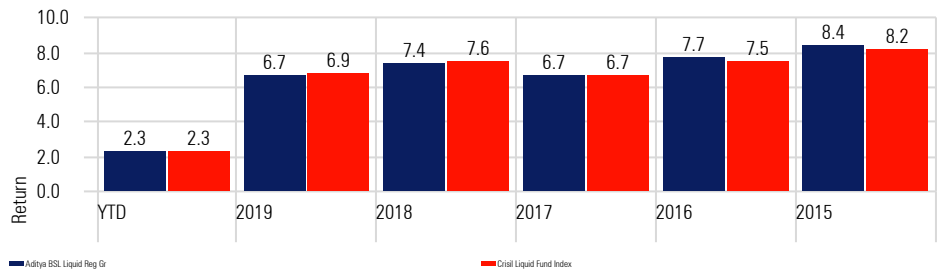
Investment Growth

Time Period: 01-06-2015 to 31-05-2020



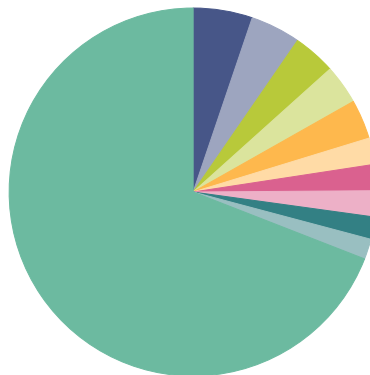

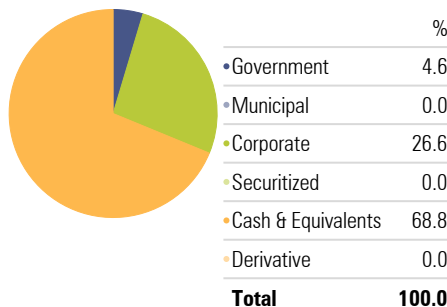
